## **Participation and payment conditions for seminar events of Campus für Weiterbildung of Technische Hochschule Ingolstadt (in the following TCW):**

### **1. Scope of application**

These terms and conditions of participation and payment apply to all paid seminar events of TCW.

### **2. Registration**

The registration for participation in advanced training events must be made in writing on a separate registration form or as an online registration at [www.thi.de/campus-fuer-weiterbildung](http://www.thi.de/campus-fuer-weiterbildung) or via e-mail to [weiterbildung@thi.de](mailto:weiterbildung@thi.de). The registration implies acceptance of these terms and conditions of participation and payment. Registrations will be considered in the order in which they are received. The contract is concluded upon receipt of the registration confirmation by TCW.

### **3. Participation fee**

The participation fee can be found in the individual events. The participation fee is due without deduction immediately upon invoicing and must be paid no later than 10 days before the start of the event. Certificates of participation will only be issued after full payment of the participation fee.

### **4. Scope of services**

The participation fee covers participation in the event and the issue of the certificate of participation. Costs for overnight stays, travel expenses, etc. are not included.

### **5. Withdrawal and termination**

The participant can withdraw from the contract up to 4 weeks before the start of an event. Participation fees already paid will be refunded in this case. If the withdrawal takes place later, the participation fee must be paid in full. The participant will be released from the payment obligation if he/she provides a substitute person and this person pays the participation fees in due time. Cancellation is only possible as extraordinary cancellation for good cause and only in written form. The cancellation is only valid for future courses. The participant's right of cancellation remains unaffected by the above provision.

## **6. Cancellation and changes**

TCW reserves the right to cancel or postpone events for important reasons (especially lack of participants). If an event has to be cancelled, the persons already registered will be informed in writing. Fees already paid will be refunded. TCW is not liable for any financial losses incurred by participants as a result of an event not taking place or of an event being cancelled. TCW reserves the right to substitute speakers other than those listed in the program in the event of a speaker cancellation.

## **7. Liability**

TCW is liable to participants for damages caused by TCW, employees, agents or vicarious agents only in cases of intent and gross negligence; this limitation of liability does not apply to damages to life, body or health. No liability is accepted for items brought in by participants.

## **8. Copyright**

The TCW is entitled to the copyrights and rights of use of the further education concept as well as the teaching aids, files and other materials that are handed out or otherwise made accessible to the participants during participation in the continuing education event. The materials may only be used for own study purposes within the framework of the continuing education event. Any use outside the limits of copyright law without the consent of the authors/right holders is not permitted and may result in claims for damages. This applies in particular to duplication, translation, microfilming and storage and processing in electronic systems as well as passing on to third parties.

## **9. Privacy**

The participant authorizes TCW to process and store the data received in connection with the event within the framework of the applicable provisions of the Data Protection Act.

## **10. General provisions**

German law shall apply. The place of jurisdiction is Ingolstadt, as far as legally permissible. Subsidiary agreements must be made in writing. Should one or more provisions of these Terms and Conditions of Participation and Payment be legally invalid in whole or in part, this shall not affect the validity of the remaining provisions. The invalid provision shall be replaced retroactively by a provision with the same content as far as possible, which comes closest to the purpose of the intended provision. The same shall apply to loopholes.

## **11. Right of withdrawal**

The participant can revoke the contract declaration within 14 days without giving reasons in text form (e.g. letter, fax, e-mail). The period begins after receipt of this instruction in text form. The timely dispatch of the revocation is sufficient to meet the revocation deadline. The revocation is to be sent to:
